

**NOTICE OF PUBLIC HEARING

Copies of the proposed budget will be available on the night of the said hearing.

NOW, therefore, BE IT FURTHER RESOLVED that the Board of Fire Commissioners of the Wading River Fire District will hold the Annual Fire District Budget Hearing to be conducted with reference to the Annual Fire District Budget for fiscal year 2018 on Tuesday, October 17, 2017, commencing at 7:00 P.M., at the Fire Headquarters District Building located at 1503 North Country Road, Wading River, New York.
