Resolution # 178

**RECINDS THAT PORTION OF RESOLUTION #140 OF 2018 WHICH AUTHORIZED  
THE TOWN CLERK TO RE-PUBLISH AND REPOST PROPOSALS FOR EPCAL  
BICYCLE PATH/VIETNAM VETERANS MEMORIAL TRAIL CONSTRUCTION  
PROJECT**

Councilwoman Giglio offered the following resolution,

which was seconded by Councilman Hubbard

**WHEREAS**, the Town Board of the Town of Riverhead, by Resolution #5, adopted on January 17, 2018, authorized the Town Clerk to publish and post a Notice to Bidders for Request for Proposals for EPCAL Bicycle Path/Vietnam Veterans Memorial Trail Construction Project; And

**WHEREAS**, the bid proposals were received and opened on February 13, 2018 at 11:00 a.m. in the Office of the Town Clerk, 200 Howell Avenue, Riverhead, NY; and

**WHEREAS**, the Engineering Department, together with a representative from the Office of the Town Attorney, did review the bid proposals and reported to the Community Development Agency and Alternate Transportation Committee that only one proposal was within the grant funding budget parameters set for the project but did not meet MWBE criteria set forth in the specifications/grant funding and all other proposals far exceeded the anticipated cost and budget for the project; and

**WHEREAS**, the Town Board accepted the recommendation of the Engineering Department, representative from the Office of the Town Attorney, and representative from the Community Development Agency, and rejected all bids submitted in response to the Request for Proposals for EPCAL Bicycle Path/Vietnam Veterans Memorial Trail Construction Project originally posted and published on January 17, 2018; and

**WHEREAS**, the Town Board of the Town of Riverhead, by Resolution #140 adopted on February 21, 2018, rejected bid proposals and authorized the Town Clerk to republish and repost notice to bidders for Request for Proposals for EPCAL Bicycle Path/Vietnam Veterans Memorial Trail Construction Project; and

**WHEREAS**, based upon outstanding components of one of the grants relied upon by the Community Development Agency and Town to fund the project, together with the potential to award under the Town's Annual Construction contract, the Community Development Agency and Town Engineering Department recommend that the Town withdraw and rescind its determination to republish and repost notice to bidders for Request for Proposals for EPCAL Bicycle Path/Vietnam Veterans Memorial Trail Construction Project.

**NOW THEREFORE BE IT RESOLVED**, that the Town Board hereby reaffirms its rejection of all bids and withdraws request for proposals for EPCAL Bicycle

Path/Vietnam Veterans Memorial Trail Construction Project and rescinds Resolution #140 of 2018 authorizing republish and repost of notice to bidders for Request for Proposals for EPCAL Bicycle Path/Vietnam Veterans Memorial Trail Construction Project; and be it further

**RESOLVED**, that all Town Hall Departments may review and obtain a copy of this resolution from the electronic storage device and, if needed, a copy of same may be obtained from the Office of the Town Clerk.

On a motion by Councilman Wooten, seconded by Councilwoman Kent, resolution #178 was **TAKEN OFF THE FLOOR**, motion carried by unanimous vote. Immediately thereafter there was a motion to put to vote, motion carried.
