**RECINDS RESOLUTION #572 OF 2018 AND WITHDRAWS REQUEST FOR BID PROPOSALS FOR SIGNAGE UTILIZED BY THE TOWN OF RIVERHEAD**

Councilwoman Giglio offered the following resolution,

which was seconded by Councilman Hubbard

**WHEREAS**, the Town Board of the Town of Riverhead, by Resolution #572, adopted on July 17, 2018, authorized the Town Clerk to republish and repost a Notice to Bidders for Signage Utilized by the Town of Riverhead; and

**WHEREAS**, the rebid proposal for Signage authorized by Resolution # 572 contains several inconsistencies and requires further clarification; and

**WHEREAS**, the Purchasing Department recommends that this Signage rebid be withdrawn and the Bid for Signage Utilized by the Town of Riverhead be revised and reissued once it is complete.

**NOW THEREFORE BE IT RESOLVED**, that the Town Board does hereby rescind Resolution #572 of 2018 authorizing republish and repost of notice to bidders for Signage Utilized by the Town of Riverhead and withdraws request for bid proposals for Signage Utilized by for the Town of Riverhead; and be it further

**RESOLVED**, that specifications and guidelines for submission of bids be removed from the Town Clerk’s Office and from the Town of Riverhead website; and be it further

**RESOLVED**, that all Town Hall Departments may review and obtain a copy of this resolution from the electronic storage device and, if needed, a copy of same may be obtained from the Office of the Town Clerk.
