AWARDS BID FOR AUTOMOTIVE PARTS 2018

Councilwoman Kent offered the following resolution,

which was seconded by Councilman Wooten

WHEREAS, the Town Clerk was authorized to publish and post a notice for sealed bids for **AUTOMOTIVE PARTS 2018** for the Town of Riverhead and;

WHEREAS, three bids were received, opened and read aloud in the Office of the Town Clerk, 200 Howell Avenue, Riverhead, NY 11901 on MARCH 13, 2018 at 2:05 pm; and

WHEREAS, the Purchasing Agent reviewed all bids and prepared a tabulation for consideration by the Municipal Garage and Town Board; and

WHEREAS, the Purchasing Agent, after review of the specifications with the Municipal Garage, to wit: due to the Town's desire to have the option to pick up parts or schedule delivery, the Town seeks a vendor located within 15 miles of the Town Municipal Garage and the successful bidder shall guarantee that all "in stock" parts shall be available for pickup during normal business hours Monday through Friday, and confirmation that Municipal Garage intends to avail itself of pick-up of parts as appropriate and necessary, determined that one bidder listed the location at a distance nearly 30 miles from the Town's Municipal Garage; and

WHEREAS, based upon the above, the Purchasing Agent recommends that the bid be awarded to Advance Stores Co. Inc. Items 1-7; 9-20; 22-35 and Riverhead Motors Inc. Items 8 & 21; and

NOW THEREFORE BE IT RESOLVED, that the Town Board accepts the recommendation of the Purchasing Agency and awards the bid for **AUTOMOTIVE PARTS 2018** as follows:

Riverhead Motors Inc. – Item 8 & 21.
Advance Stores Co., Inc. - Items 1-7; 9-20; 22-35.
