**WHEREAS**, the Town Purchasing Agent has requested that the contract with the above mention vendor be extended for one (1) year beginning JUNE 20, 2018 until JUNE 20, 2019; and

**WHEREAS**, this is the second extension requested of an allowable 3 years.

**WHEREAS**, GALLS, LLC has agreed to extend the contract price until JUNE 20, 2019 for the original prices, terms and conditions set forth in the original contract.
